Re: *State of Ohio vs. Randall J. Daley*, 13-CR-0094

Yesterday after a two day jury trial in the Seneca County Common Pleas Court, Randall J. Daley was convicted of four (4) counts of endangering children and one count of kidnapping for the abuse of a child on July 8-10, 2011 at Pelton's Trailer Park near Fostoria.

The twenty-two month old child had been initially treated at Fostoria Community Hospital and then transferred to Toledo Children's Hospital. The child suffered serious physical harm including extensive bruises on her face, arms, legs, back, and torso. She also had suffered a first degree burn over a significant portion of her body after being held in a hot bath.

Mr. Daley's then girlfriend, Tellina Tenney, had been convicted for her role in the abuse in 2012 and is serving a fourteen (14) year term of imprisonment.

Judge Hein of Darke County presided over the trial as he had been appointed as a visiting judge by the Ohio Supreme Court. Judge Hein ordered a pre-sentence investigation report and sentencing will be scheduled upon completion of that report. Mr. Daley faces a maximum term of imprisonment of twenty-six (26) years.

Seneca County Prosecutor Derek W. DeVine handled the prosecution of this case from the investigation through trial. DeVine commended the efforts of the medical and law enforcement officials, "Officers Brian and Taggart from the Fostoria Police Department were the initial law enforcement presence in this case and developed vital information for the successful prosecution of this matter". Seneca County Sheriff's Department Detective Sgt. Kevin Reinbolt took over the investigation after it was determined that the abuse happened in the county.

"The professionalism of the staff at the Fostoria Community Hospital, the Fostoria Police Department, and the Seneca County Sheriff's Office while dealing with such dramatic abuse of a child is amazing", concluded DeVine.

Mr. Daley was represented by Tiffin attorney Mark Klepatz.
